CANCELLATION POLICY

If cancellation is made by the client prior to 120 business days from the start of the event, the client will incur a cancellation fee of 50% of the total sponsorship costs contracted.

If cancellation is made by the client prior to 90 business days from the start of the event, the client will incur a cancellation fee of 75% of the total sponsorship costs contracted.

If cancellation is made by the client in the 90 business days before the event, there will be no refund and all costs contracted for must be paid in full. The unpaid balance is due at the time of the cancellation.

All notice of cancellation must be received in writing.

The organiser shall not be liable for any loss caused by the cancellation of the event where such cancellation is due to Force Majeure. The term "Force Majeure" means any circumstance beyond the reasonable control of the organisers including but not limited to War, hostilities, terrorism, aircraft hijacking, military operation, riot, civil war, rebellion, civil commotion or unrest, Acts or Regulations of government,... The organisers will use all reasonable efforts to conduct the conference despite the intervention or occurrence of any such cause.

PAYMENT

The total amount is due upon receipt of the invoice. A late charge of 1.5% / month will be added to any unpaid balance.

Invoicee is responsible for all legal and accounting fees resulting from non-payment.
